To conduct research into silviculture, utilization and other problems affecting the regeneration and development of the forests. To achieve the goals of National Forest policy 1988 and to cover the maximum area under forests. To create awareness among the people about the forests and environment. To increase the active participation of the local people in protection and conservation of forest with special emphasis on tribal, poor and women.
